

Keesridge Stud Dog Contract (Natural or fresh chilled/frozen semen)

The stud fee agreed upon is \$_____ and is payable in full prior to litter registration being signed

Payment as follows: \$500 non refundable time of service breeding fee.

Balance of \$_____ due prior to litter registration being signed.

Repeat breeding if no litter: \$500 non refundable time of service breeding fee.

Balance of \$_____ (original stud fee balance minus 2 x \$500 service fees), due prior to litter registration being signed.

Natural breedings: All shipping costs and health fees to ship the bitch are the responsibility of the bitch's owner. If the bitch is traveling to the stud dog owner's (or representative's) house, the stud dog owner agrees to take the utmost care in providing a safe home for the bitch, and ensure that natural breedings are done carefully and safely.

Artificial Insemination breedings: If the owner of the of the bitch decides to have an artificial insemination breeding either via fresh chilled or 'fresh' frozen from a live dog, or the breeding must occur through artificial insemination, all costs incurred to collect the semen and artificially inseminate the bitch, will be paid by the bitch's owner. These fees are in addition to the stud fee.

In entering this contract as owner of the bitch above, I agree to the conditions:

1. The bitch shall be x-rayed and certified free of hip dysplasia, elbow dysplasia, patellar luxation and will have a Normal eye certification. She must be PHPT Negative, either by direct testing, or by descent with proof provided. Brucellosis testing is to be run on the bitch with a negative result, prior to being bred.
2. The bitch must be seizure free in her lifetime before this breeding, and has not produced any puppies with seizures at time of breeding.

3. If at least three (3) puppies do not survive to the age of eight weeks, bitch owner is to notify stud dog owner at no later than eight weeks past the whelp date. The bitch owner will be given the option of:

a) one repeat service within two seasons of whelp/due date to any other mutually approved stud dog at Keesridge, or

b) one breeding to any other “ approved” bitch, bitch owner owns or leases, within one year of whelp/due date

This does not apply if the puppies are lost secondary to neglect or trauma. Should no puppies result from either service, or should bitch owner(s) not wish to proceed with the repeat breeding, the breeding service fee is non-refundable and neither party will be further obligated. The balance of the stud fee would only be due if the repeat was successful in producing more than three puppies. All expenses for a repeat breeding will be paid for by the owner of said bitch.

4. The bitch’s owner will be responsible for all transportation charges, to and from the sire owner’s residence.
5. The bitch’s owner will be responsible for any veterinary charges incurred in the breeding of their bitch. The stud dog owner will contact them prior to any charges incurred to discuss the procedures or questions that the stud dog owner feels may be necessary to properly breed the bitch. If bitch needs medical attention while in stud dog owner’s care, bitch owner will be contacted first, with the exception of a medical emergency.
6. The bitch is to be maintained in good health while in whelp and during nursing period.
7. The bitch is to be confined after breeding until she is out of heat to avoid possible mistake breedings. Should such a breeding take place, the stud dog owner will not sign the registration papers until the appropriate DNA testing is conducted per AKC/CKC guidelines.
8. The contact information (name, address, phone, e-mail) of all puppy buyers is to be provided to the stud dog owner, just for record keeping.
9. All puppies graded as pet stock shall be sold on non-breeding agreements and as written in their contracts. No offspring will be offered for sale to or through a pet shop, grooming parlour, humane organization, or puppy mill kennel.

10. All puppies will be individually registered with the registering country in which they are born (Canadian Kennel Club or American Kennel Club), and at no higher cost.
11. Both owners of the stud and bitch agree to abide by the Breeders Code of Ethics as designed by the Keeshond Club of America and/or Keeshond Club of Canada.

In entering this contract as owner of the stud dog above, I agree to the conditions:

1. Have a semen evaluation completed prior to entering into stud contract.
2. The stud dog has been x-rayed and certified free of hip dysplasia, elbow dysplasia, patellar luxation and has a Normal eye certification. He has been tested negative for PHPT. Brucellosis testing is to be run on the stud dog, with a negative result, prior to being bred/collected.
3. The stud dog's pedigree, and OFA results will be provided to the bitch owner before the breeding.
4. Have the stud dog in good physical condition.
5. The stud dog must be seizure free in his lifetime before this breeding, and has not produced offspring with seizures as of date of breeding.
6. Upon completion of payment, sign litter registration and promptly return to bitch owner.
